**SCHEDULING ORDER FOR COMMENCEMENT OF TRIAL**

**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”),

**NOTING** that on 27 March 2013, Radislav Krstić (the “Accused”) was charged with contempt of the Tribunal pursuant to Rule 77(A) of the Tribunal’s Rules of Procedure and Evidence (“Rules”) for having refused to testify in the case of *Prosecutor v Radovan Karadžić* (“*Karadžić Case*”) on several occasions, including on 7 February 2013 and 25 March 2013, and therefore knowingly and wilfully interfering with the administration of justice by refusing to comply with the Chamber’s subpoena and an addendum thereof;<sup>1</sup>

**NOTING** the initial appearance of the Accused on 4 April 2013, during which the Accused maintained that he would not testify in the *Karadžić Case*, and pleaded not guilty to the contempt charge;<sup>2</sup>

**CONSIDERING** that Counsel for the Accused, Mr. Tomislav Višnjić, has indicated on 22 April 2013, via email to the Chamber that the Defence will be prepared for the trial to commence by 21 May 2013;

**CONSIDERING** that it is in the interests of justice that the trial of the Accused be held as soon as practicable;

**PURSUANT TO** Article 20 of the Statute of the Tribunal and Rules 54 and 73 *bis* of the Rules;
