**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”),

**NOTING** that on 27 March 2013, Radislav Krstić (“Accused”) was charged with contempt of the Tribunal pursuant to Rule 77(A) of the Tribunal’s Rules of Procedure and Evidence (“Rules”) for knowingly and wilfully interfering with the administration of justice by refusing to comply with the subpoena and the addendum to the subpoena issued by the Chamber which ordered him to appear and testify in the case of *Prosecutor v. Radovan Karadžić* (“Karadžić case”);<sup>1</sup>

**NOTING** that on 4 April 2013, at the initial appearance of the Accused, he maintained that he would not testify in the *Karadžić* case and pleaded not guilty to the charge of contempt;<sup>2</sup>


**NOTING** that the trial of the Accused was held on 28 May 2013;<sup>3</sup>

**NOTING** that the Chamber thereafter deliberated pursuant to Rule 87(A) of the Rules;

**PURSUANT TO** Rule 98 *ter* of the Rules;

**HEREBY SCHEDULES** the pronouncement of the Judgement for Thursday, 18 July 2013, at 4 p.m. in Courtroom I.
