SCHEDULING ORDER FOR COMMENCEMENT OF TRIAL AND ORDER TERMINATING PROVISIONAL RELEASE

**TRIAL CHAMBER III** ("Trial Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

**RECALLING** that Jelena Rašić was granted provisional release on 12 November 2010, on conditions, *inter alia*, that she return to the Tribunal at such time and on such date as the Chamber may order;<sup>1</sup>

PURSUANT TO Articles 20 and 29 of the Statute and Rules 54, 65 and 73 bis of the Rules;

#### **ORDERS** that:

- (A) A pre-trial conference shall be held on 9 January 2012 at a time and in a courtroom to be designated by the Registry;
- (B) The trial shall commence on Monday 9 January 2012 following the pre-trial conference;

**ORDERS** Jelena Rašić to return to the United Nations Detention Unit by Friday 6 January 2012, thereby terminating her provisional release;

**REQUESTS** the Government of the Republic of Serbia to ensure that Jelena Rašić is transported, under guard, from Belgrade, Republic of Serbia, to Schiphol Airport or any other airport in the Netherlands and released into the custody of the designated officers of the Government of the Kingdom of the Netherlands;

**REQUESTS** the Government of the Kingdom of the Netherlands to ensure that Jelena Rašić is transported, under guard, from Schiphol Airport or any other airport in the Netherlands to the custody of the United Nations Detention Unit; and

**ORDERS** the Registry to make all necessary arrangements, including to liaise with the Governments of the Kingdom of the Netherlands and of the Republic of Serbia, to enable Jelena Rašić to return on Friday 6 January 2012.
