

**I, PATRICK ROBINSON,** President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("International Tribunal"),

**NOTING** the "Motion by Professor Vojislav Šešelj for the Disqualification of Judges O-Gon Kwon and Kevin Parker", filed confidentially and in English by Mr. Vojislav Šešelj on 27 April 2010 ("Motion");<sup>1</sup>

**NOTING** the "Decision on Motion by Professor Vojislav Šešelj for the Disqualification of Judges O-Gon Kwon and Kevin Parker", issued by myself on 22 June 2010, in which I appointed a panel of three Judges, including Judge Christoph Flügge, Judge Howard Morrison, and Judge Guy Delvoie, to consider the merits of the Motion;<sup>2</sup>

**NOTING** that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal authorizes the President to coordinate the work of the Chambers;

CONSIDERING the trial management and case distribution needs of the International Tribunal;

**HEREBY ASSIGN** Judge Alphons Orie to replace Judge Christoph Flügge on the Bench considering the Motion.
