HAVING DESIGNATED MYSELF Pre-Trial Judge in the case of *Prosecutor v. Milorad Trbić*, Case No. IT-05-88/1-PT, by order of 3 July 2006;¹

NOTING Rule 65bis of the Rules of Procedure and Evidence of the Tribunal ("Rules") which provides, *inter alia*, that a status conference shall be convened within one hundred and twenty days after the last status conference to i) organise exchanges between the parties so as to ensure expeditious preparation for trial; and ii) to review the status of his or her case and to allow the accused the opportunity to raise issues in relation thereto, including the mental and physical condition of the accused;

NOTING that the last Status Conferences in the present case was held on Friday 24 November 2006;

NOTING FURTHER the "Scheduling Order for a Status Conference" issued by me on 8 March 2007, wherein I had scheduled the next Status Conference for Milorad Trbić on Friday 23 March 2007, commencing at 2.30 p.m. in Courtroom III of the Tribunal;

NOTING an unforeseen change of circumstances;

FOR THE FOREGOING REASONS

PURSUANT TO Rule 65bis of the Rules:

HEREBY RESCHEDULE a Status Conference for Milorad Trbić on Friday 23 March 2007, commencing at 3.30 p.m. in Courtroom III of the Tribunal.
