PROSECUTOR'S SEVENTH PROGRESS REPORT

- 1. Pursuant to the Decision on Prosecutor's Motion for Referral of Case Pursuant to Rule 11bis of 20 July 2005¹ ("Referral Decision") the Office of the Prosecutor ("OTP") hereby files its seventh progress report in this case.
- 2. The Decision on Referral requires that following the initial report, six weeks after transfer of material, the OTP must file a report every three months on the course of the proceedings before the State Court of Bosnia and Herzegovina.²
- 3. The OTP filed its sixth progress report on 3 October 2007.³
- 4. Following the agreement between the Chairman in Office of the Organisation for Security and Co-operation in Europe's Mission to Bosnia and Herzegovina (the "OSCE") and the Prosecutor, the OTP received OSCE's sixth report on 26 December 2007. The Report outlines the main findings of trial monitoring activities to date in the *Mejakić et al* case, from the perspective of international human rights standards. 5

- 5. OSCE has not identified any issues of concern that could be assessed, at this stage, as infringing upon the Defendants' right to a fair trial.⁶
- 6. The OSCE summarises the proceedings in the *Mejakić et al.* case to date as follows: ⁷
 - The prosecution completed presentation of its case on 30 November 2007. A total of 55 hearings was held, 45 witnesses were herad and 201 pieces of evidence were tendered into evidence;
 - The Defence began presenting its case on 11 December 2007, by giving its opening statements;
 - During the reporting period, 16 main trial hearings were held during which 5 prosecution witnesses were heard. The hearings were mainly heard in public. The public was only excluded when applications for protective measures were discussed and for parts of testimonies when it was necessary to reinforce previously ordered measures of protection and to prevent that the identity of protected witnesses is revealed;
 - Regular review of custody has been conducted and it was held that custody against the Defendants is still justified on the bases of the risk of flight and threat to public security.; and
 - The main trial will resume on 10 January 2008, when the first defence witness will be heard.
- 7. The Report reiterates OSCE's continued concern regarding the lack of justification by the BiH Court when relying on the potential threat to public and property security as a ground for pre-trial detention, an issue previously mentioned in the *Janković*, *Ljubičić* and *Rašević* and *Todović* cases as well as in the previous reports in the *Mejakić* case. While the OTP understands and gives due regard to this issue it considers that at present it does not appear to affect the right to a fair trial of these four Accused.
- 8. The OSCE also reports that on 6 December 2007, Vinko Kondić, an additional defence counsel for Momčilo Gruban, was arrested under suspicion that he committed crimes against humanity in the Ključ Municipality in 1992. At this stage the OSCE

reports that there are no reasons to believe that this event has had an adverse effect on the rights of the Accused in this case.

SUMMARY OF DEVELOPMENTS

The case against Željko Mejakić, Momčilo Gruban, Dušan Fuštar and Duško Knežević (*Mejakić et al.* case, the "Accused" or "Defendants") is the third case referred from the ICTY to the State Court of BiH, pursuant to Rule 11*bis* of the ICTY Rules of Procedure and Evidence. This constitutes the sixth report submitted by the OSCE Mission to Bosnia and Herzegovina ("OSCE-BiH" or "Mission") to the ICTY Prosecutor's Office in the *Mejakić et al.* case, covering the period between 20 September 2007 and 24 December 2007.

From its monitoring activities during the reporting period, the Mission has not identified any issues of concern at this stage. However, the Mission reiterates its observations related to the application and justification of the potential threat to public and property security as grounds for pre-trial custody as well as those related to the limited application of alternatives to custody; both have been already extensively addressed in previous OSCE-BiH reports. Therefore, this Report mainly consists of a short summary of the developments in the present trial proceedings.

The proceedings within this reporting period may be summarised as follows:

- The Prosecution completed presentation of its case on 30 November 2007, after 55 hearings, a
 total of 45 prosecution witnesses heard and 201 pieces of material documentation tendered
 into evidence. The Defence began presenting its case, giving its opening statements on 11
 December 2007.
- During this reporting period, 16 main trial hearings² were held. Five prosecution witnesses were heard.³ The hearings were mainly held in public. The public was only excluded to discuss the application of protective measures and for parts of the witness' testimonies when it was necessary to reinforce previously ordered measures of protection and to prevent the identity of protected witnesses from being revealed.
- The judges conducting regular reviews of custody held that custody against the Defendants is still justified on the bases of the risk of flight and of threat to public security, as initially ordered by the Preliminary Hearing Judge.
- The main trial will resume on 10 January 2008, when the first defence witnesses will be heard.

It should be mentioned that Mr. Vinko Kondić, the additional Defence Counsel of Momčilo Gruban, was arrested on 6 December 2007 under suspicion of having committed crimes against humanity in the area of Ključ Municipality in the period from April 1992 until December 1992. On 7 December 2007, the preliminary hearing judge issued a decision ordering one month custody against Mr. Kondić on the grounds of risk of flight, risk of interference with the criminal proceedings by influencing the witnesses or possible accomplices, and threat to public security. At this stage, there is no reason to

believe that these events have had an adverse effect on the rights of the Defendants. The OSCE-BiH will continue to follow closely the developments in this matter. In the meantime, the Mission remains available for any further information on this issue.
