From about May 1992 to about December 1995, in Sarajevo, Bosnian Serb military forces, on a widespread and systematic basis, deliberately or indiscriminately fired on civilian targets that were of no military significance in order to kill, injure, terrorise and demoralise the civilian population of Sarajevo.

## INDICTMENT AND CHARGES

The indictment, confirmed on 29 February 1996, alleged that Đorđe Đukić was a member of the Main Staff of the Bosnian Serb army from 19 May 1992. The Main Staff was responsible for the planning, preparation and execution of Bosnian Serb military operations in Bosnia and Herzegovina. The indictment further stated that Đorđe Đukić was the Assistant Commander for Logistics.

It was alleged that Đorđe Đukić, in concert with others, planned, prepared or otherwise aided and abetted in the planning and preparation of the acts and operations of the Bosnian Serb army and its agents. These acts and operations included the shelling of civilian targets. From about May 1992 to about December 1995, in Sarajevo, Bosnian Serb military forces, on a widespread and systematic basis, deliberately or indiscriminately fired on civilian targets that were of no military significance in order to kill, injure, terrorise and demoralise the civilian population of Sarajevo.

Đorđe Đukić was charged on the basis of individual criminal responsibility (Article 7(1) of the Statute) with:

- · Inhumane acts (crimes against humanity, Article 5)
- · Inhumane acts (violations of the laws or customs of war, Article 3)

# TERMINATION OF PROCEEDINGS

Đorđe Đukić was released on 24 April 1996 on grounds of ill-health, and died on 18 May 1996. On 29 May 1996, the Appeals Chamber issued the decision terminating trial proceedings against the accused.
