**TRIAL CHAMBER I** (“Trial Chamber”) of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**NOTING** the “Decision on the Prosecution’s Motion for Reconsideration of the Chamber’s Decision on Admission of Documentary Evidence”, rendered on 13 February 2008 (“Decision”), whereby the Trial Chamber admitted into evidence a number of items tendered from the bar table;

**HEREBY ORDERS** that paragraph 18, a) of the disposition of the Decision should read as follows:


a) The following Proposed Exhibits are admitted into evidence:
