ORDER LIFTING CONFIDENTIALITY OF THE DECISION ON PROSECUTION'S MOTION TO REOPEN ITS CASE

TRIAL CHAMBER I ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

NOTING the Chamber's Decision on Prosecution's Motion to Reopen Its Case, filed confidentially on 21 April 2010 ("Decision");

NOTING that the Chamber announced on 22 April 2010 that a public version of the Decision would be made available in due course; 1

CONSIDERING that the Decision was issued confidentially in the event that the prospective witnesses named therein were to testify under protective measures;

CONSIDERING that Witnesses Bilobrk, Gerovac and Mikulić, who were named in the Decision, testified for the Prosecution on 2-3 June 2010, provisionally in private session, that they did not request protective measures,² and that the Chamber lifted the confidential status of their testimony on 7 June 2010;³

CONSIDERING that Witness Vrtičević, who was named in the Decision, testified publicly for the Čermak Defence on 10 June 2010 and did not request any protective measures;⁴

FINDING no reason to keep the Decision confidential;

NOTING that none of the parties objected to lifting the confidential status of the Decision;⁵

LIFTS the confidential status of the Decision; and

ORDERS pursuant to Rule 54 of the Tribunal's Rules of Procedure and Evidence that the Registrar of the Tribunal adjust the status of the Decision accordingly.
