**Order to Redact the Public Transcript
and the Public Broadcast of a Hearing**

The Trial Chamber

ORDERS that the following blacked-out text, transcript page 55, line 15 – page 56, line 10, be omitted from the public transcript and be edited from the public broadcast of the hearing on 10 September 2014.
