ORDER RECALLING LAHI BRAHIMAJ FROM PROVISIONAL RELEASE

THE APPEALS CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Appeals Chamber" and "International Tribunal", respectively),

RECALLING the "Decision on Lahi Brahimaj's Application for Provisional Release", issued on 27 May 2009 ("Provisional Release Decision"), which provisionally released Lahi Brahimaj subject to him returning to the United Nations Detention Unit ("UNDU") in The Hague at a time to be determined by the Appeals Chamber; ¹

NOTING the "Scheduling Order for Pronouncement of Judgement", issued by the Appeals Chamber on 2 July 2010, ordering that the Judgement in this appeal shall be pronounced in public on Wednesday, 21 July 2010 at 9:30 a.m.;

NOTING that the Provisional Release Decision required the EULEX-Kosovo Mission to assume "responsibility ... for all expenses concerning the transportation of Lahi Brahimaj from Priština airport to his residence and back";²

PURSUANT to Rule 65 of the Rules of Procedure and Evidence of the International Tribunal:

HEREBY ORDERS that:

- 1. Lahi Brahimaj shall return to the UNDU in The Hague for the pronouncement of the Judgement in his case;
- 2. the EULEX-Kosovo Mission shall designate an official who will accompany Lahi Brahimaj from his place of residence in Kosovo/Kosova and who will deliver him at Priština airport into the custody of a security officer designated by the Registrar of the International Tribunal;
- 3. the EULEX-Kosovo Mission shall ensure the personal security and safety of Lahi Brahimaj until he is delivered into the custody of the International Tribunal's security officer at Priština airport;
- 4. the authorities of The Netherlands shall ensure that Lahi Brahimaj is transported, under guard, from Schiphol Airport to the UNDU;

5. the Provisional Release Decision shall be stayed for the pronouncement of the Judgement,

pending any further order from the Appeals Chamber;

HEREBY INSTRUCTS that:

6. the Registrar of the International Tribunal shall consult with the Dutch Ministry of Justice

with regard to the practical arrangements for Lahi Brahimaj's return to the UNDU;

7. the EULEX-Kosovo Mission, The Netherlands, and the Registry of the International

Tribunal shall communicate with each other to facilitate the orderly return of Lahi Brahimaj

to the UNDU;

HEREBY REQUESTS that the authorities of all States through whose territory Lahi Brahimai

may travel:

8. shall hold Lahi Brahimaj in custody for any time that he will spend in transit; and

9. shall arrest and detain Lahi Brahimaj, should he attempt to escape during his transfer to the

UNDU in The Hague.
