THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the Territory

of the former Yugoslavia since 1991 ("Tribunal");

BEING SEISED of the Accused's "Motion for Order Pursuant to Rule 70", filed on

9 February 2008 ("Motion"), whereby the Accused requests the Trial Chamber to issue an order

pursuant to Rules 54 and 70 of the Rules of Procedure and Evidence of the Tribunal ("Rules") to the

effect that the provisions of Rule 70 should apply to any information provided by the Government

of the United States of America in response to the Accused's request outlined in a letter dated

11 December 2008;¹

NOTING that the Accused has not submitted with the Motion any confirmatory material from the

Government of the United States of America but merely refers to "a meeting on 4 February 2009,

[in which] the United States Legal Counselor ... expressed the willingness of the United States to

search for and provide material responsive to the request, and to make Ambassador Goldberg

available for an interview, so long as a Rule 70 order was obtained";²

CONSIDERING that, in order to determine the Motion, the Trial Chamber needs to be satisfied

that the Government of the United States of America has consented to produce the information

sought on the condition that the provisions of Rule 70 will apply;

CONSIDERING that the Trial Chamber would be assisted by any information and comments the

Government of the United States of America can provide on its communication with the Accused to

- (a) **INVITES** the Government of the United States of America, within 14 days from the date of service of this Invitation, to assist the Trial Chamber by providing the information referred to above; and
- (b) **REQUESTS** the Registry to provide both the Motion and this Invitation to the Government of the United States of America.
