NOTING the letter from the Registrar to Mr. Radovan Karadžić dated 11 September 2009;<sup>1</sup>

**NOTING** the public with confidential annex B "Request for Reversal of Limitations of Contact with Journalist: *Le Monde*" ("Motion"), filed before me by Radovan Karadžić on 17 September 2009;

**CONSIDERING** that my prior role as Presiding Judge of the Pre-Trial Bench in the present case<sup>2</sup> gives rise to a conflict of interest and that, in accordance with Rule 15(A) of the Rules of Procedure and Evidence of the International Tribunal ("Rules"), I shall therefore withdraw from considering the Motion;

**CONSIDERING** that Vice-President Judge O-Gon Kwon has advised me that his current role as Presiding and Pre-trial Judge in the present case<sup>3</sup> gives rise to a conflict of interest and that, in accordance with Rule 15(A) of the Rules, he therefore withdraws from considering the Motion;

**CONSIDERING** Rule 64*bis* of the Rules of Detention and Rule 22(A) of the Rules;

**HEREBY ASSIGN,** with immediate effect, Judge Mehmet Güney to consider the Motion in place of myself.
