**ORDER REVISING DECISION ON THE PROSECUTION'S MOTION FOR SAFE

THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”),

NOTING the “Decision on the Prosecution’s Motion for Safe Conduct for Witness Momčilo Mandić”, issued 16 June 2010, in which this Trial Chamber granted the confidential “Prosecution’s Motion for Safe Conduct for Witness Momčilo Mandić”, filed on 2 June 2010, requesting safe conduct for Momčilo Mandić from 25 June 2010 to 3 July 2010;

NOTING the disposition of the “Decision on the Prosecution’s Motion for Safe Conduct for Witness Momčilo Mandić”, issued 16 June 2010, stating that the “Chamber may vary or extend the dates for which the order for safe conduct is valid in light of any change in the current witness schedule”;

CONSIDERING the Chamber’s revised schedule for hearing the testimony of Momčilo Mandić;

PURSUANT TO Rule 54 of the Tribunal’s Rules of Procedure and Evidence;

HEREBY ORDERS that the applicable dates of the order for safe conduct for Momčilo Mandić shall be revised to the effect that it remains valid up to and including 17 July 2010, or until another date and time to be notified, **REQUESTS** the Registrar of the Tribunal to take all necessary measures for the implementation of the order for safe conduct through the revised date, and **CONFIRMS** the continuance in force of all other terms of the order for safe conduct.
