THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal"),

ex proprio motu;

NOTING the "Order Assigning Judges to a Case Before a Trial Chamber", issued by the President of the Tribunal on 28 June 2006, which ordered that the Bench in the above-captioned proceeding shall be composed of Judge Iain Bonomy (Presiding), Judge Ali Nawaz Chowhan, and Judge Tsvetana Kamenova;

NOTING that the Trial Chamber's "Pre-trial Order and Appended Work Plan", issued 5 April 2006, set forth 7 July 2006 as the date for the pre-trial conference and 10 July 2006 as the date for the commencement of the trial;

CONSIDERING that it would assist the conduct of the trial for the Trial Chamber to issue a scheduling order in these proceedings for the pre-trial conference, the commencement of the trial, and the first two weeks of the trial, including the places where and times during which the hearings on those days shall be held;

PURSUANT TO Rules 54 and 62 of the Rules of Procedure and Evidence,

- 3. The trial shall continue on Tuesday to Thursday, 11–13 July 2006 in Courtroom 1,
 - a. from 2:15 p.m. to 3:45 p.m.;
 - b. from 4:05 p.m. to 5:35 p.m.; and
 - c. from 5:55 p.m. to 7:00 p.m.
- 4. The trial shall continue on Friday, 14 July 2006, in Courtroom 1,
 - a. from 9:00 a.m. to 10:30 a.m.;
 - b. from 10:50 a.m. to 12:20 p.m.; and
 - c. from 12:40 p.m. to 1:45 p.m.
- 5. The trial shall adjourn for the summer recess from 17 July to 4 August 2006.
- 6. The trial shall resume on Monday to Wednesday, 7–9 August 2006 in Courtroom 1,
 - a. from 9:00 a.m. to 10:30 a.m.;
 - b. from 11:00 a.m. to 12:30 p.m.;
 - c. from 2:00 p.m. to 3:30 p.m.; and
 - d. from 4:00 p.m. to 5:30 p.m.
- 7. The trial shall continue on Thursday, 10 August 2006 in Courtroom 1,
 - a. from 9:00 a.m. to 10:30 a.m.;
 - b. from 10:50 a.m. to 12:20 p.m.; and
 - c. from 12:40 p.m. to 1:45 p.m.
- 8. The trial shall continue on Friday, 11 August 2006 in Courtroom 1,
 - a. from 9:00 a.m. to 10:30 a.m.;

b.	from	11:00	a.m.	to	12:30	p.m.;
