
THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) is seised of “Sreten Lukić’s Request Regarding Exhibit 6D692,” filed on 4 December 2007; “Sreten Lukić’s Request Regarding Exhibit 6D704,” filed on 4 December 2007; “Sreten Lukić’s Request Regarding Exhibit 6D712,” filed on 4 December 2007; “Sreten Lukić’s Request Regarding Exhibit 6D1318,” filed on 4 December 2007; and “Sreten Lukić’s Request Regarding Exhibit 6D1416,” filed on 4 December 2007 (“Motions”), and hereby issues this order thereon.

1. On 17 October 2007, exhibit 6D712, entitled “Prk Command – Order to crush and destroy ŠTS in region of Drenica – 1 mountain,” was marked for identification in eCourt pending translation. On 23 October 2007, exhibit 6D1318, entitled “Prk Command, Order for unblocking of DTS and active actions, village of Junik,” was marked for identification in eCourt pending translation. On 13 November 2007, the following exhibits were marked for identification in eCourt pending translations: exhibit 6D692, entitled “Preparing order for support of MUP forces”; exhibit 6D704, entitled “Prk Command – Order to crush and destroy ŠTS in region ‘Bajgora – 2’”; and exhibit 6D1416, entitled “Prk Command, Plan of actions for crush and destroy ŠTS in Drenica and Podujevo region.” The Lukić Defence informs the parties and the Trial Chamber that the aforementioned exhibits have been translated into English and uploaded to eCourt. Further, the Lukić Defence requests that the exhibits and their translations be admitted into evidence.

2. The Prosecution has indicated that it does not intend to oppose the Motions.

3. Accordingly, the Trial Chamber, pursuant to Rules 54 and 89 of the Rules of Procedure and Evidence of the Tribunal, hereby GRANTS the Motions and ORDERS that the following documents and their translations be admitted into evidence: 6D692, 6D704, 6D712, 6D1318, 6D1416.
