**TRIAL CHAMBER III** ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

**NOTING** the motion to admit evidence relative to Witness Žarko Primorac, filed by the Office of the Prosecutor ("Prosecution") on 30 June 2008<sup>1</sup> ("Motion"), in which the Prosecution requested the admission of P 10467, among others, without specifying the page numbers requested for admission,

**NOTING** the "Order to Admit Evidence Relative to Witness Žarko Primorac", rendered by the Chamber on 21 July 2008 ("Order of 21 July 2008"), in which it ruled on the Motion, among other things,

**CONSIDERING** that with regard to Exhibit P 10467 requested for admission by the Prosecution, the Annex attached to the Order of 21 July 2008 marks it as follows:

"Admitted",

CONSIDERING that the Chamber notes at present that pages 1 to 8 of Exhibit P 10467 translated into English and uploaded to the ecourt system as ET-0180-6872 were already admitted by the "Order Admitting Evidence Related to Witness Mile Akmadžić" rendered by the Chamber on 17 July 2008,

**CONSIDERING** that the Motion concerning them was consequently moot; which should have been reflected by the Order of 21 July 2008,

**CONSIDERING** that the disposition should now be corrected in this regard,

CONSIDERING that the Chamber furthermore reminds the Parties that pursuant to Guideline 8, when a party presents only an excerpt of an exhibit at the hearing, it must limit itself to requesting the admission into the case file of this excerpt and the pages that will permit the Chamber to rule on the authenticity of the exhibit, and to this end it must provide the Chamber with the numbers of the pages and/or paragraphs of the exhibit corresponding to the excerpt that it intends to request for admission,<sup>2</sup>

**CONSIDERING** that in the Motion, the Prosecution did not specify the pages of Exhibit P 10467 that it was requesting for admission,

**CONSIDERING** consequently that in the Order of 21 July 2008 the Chamber should not have admitted Exhibit P 10467 in its entirety and the disposition should now be corrected in this regard,

# FOR THE FOREGOING REASONS,

PURSUANT TO Rules 54 and 89 of the Rules of Procedure and Evidence,

**ORDERS** the Annex to the Order of 21 July 2008 with regard to Exhibit P 10467 to be amended as follows:

"P 10467: Partially <u>moot</u> (reason: pages 1 to 8 in English ET-0180-6872 were already admitted on 17 July 2008) and <u>not admitted in all other respects</u> (reason: the Prosecution did not specify the pages requested for admission).
