PROSECUTION'S CORRIGENDUM TO ANNEX V TO THE THIRD AMENDED INDICTMENT

- 1. The Prosecution hereby files a corrigendum to Annex V to the *Third Amended* Indictment.¹
- 2. On 7 December 2007, the Prosecution filed the *Third Amended Indictment*. As mentioned in the *Prosecution's Notice of Compliance with Decision of 27 November 2007*, the indictment included "... the updated Annexes for victims from crime sites located in Mostar, Nevesinje, Zvornik, and Vukovar" which "... corrected names and updated the lists of victims to conform to the evidence to be presented at trial."²
- 3. The Prosecution has realised that Annex V, listing the alleged victims of crimes in Zvornik includes only the first of several tables, and consequently includes only five victims.³ The remaining tables were inadvertently omitted due to a word processing in compiling the tables for filing. Attached hereto is the complete Annex V, including all tables, to correct this mistake.
- 4. The corrigendum does not prejudice the Accused. First, Annex V includes only victims that are mentioned in the statements of witnesses that have been disclosed to the Accused pursuant to Rule 66(A). He was therefore fully aware that the Prosecution intends to lead evidence about the death of the people listed

in Annex V. Second, the Accused repeatedly has stated that he is not contesting that the victims listed in the indictment are dead, but maintains that he is not responsible for their deaths. As the Accused is not contesting the Prosecution's case on this point, he cannot be prejudiced by the filing of the corrigendum. Third, comparison of the prior versions of Annex V, which included many more than five victims, readily demonstrates that the version of Annex V filed with the *Third Amended Indictment* is incomplete. Finally, indeed the Accused has not been under any misapprehension as to the charges against him as evidenced from the fact that he has did not object to the admission evidence regarding victims not included in the erroneous version of Annex V filed with the *Third Amended Indictment*.⁴
