I, THEODOR MERON, President of the International Tribunal for the Prosecution of Persons

Responsible for Serious Violations of International Humanitarian Law Committed in the Territory

of the former Yugoslavia since 1991 ("Tribunal");

NOTING the confidential "Motion to Instigate Proceedings against Carla del Ponte" filed by

Mr. Vojislav Šešelj ("Šešelj") on 16 October 2013 ("Motion");

NOTING the confidential "Order regarding a Motion for the Initiation of Contempt Proceedings"

rendered by the President of the Tribunal on 11 November 2013 ("Order"), assigning the Motion

to the bench hearing the proceedings in Prosecutor v. Vojislav Šešelj, Case No. IT-03-67-T

("Trial Chamber");

NOTING the "Decision on 'Motion to Instigate Proceedings against Carla del Ponte" rendered by

the Trial Chamber on 16 June 2014, declining to consider the Motion on the basis that the Trial

Chamber is not competent in view of the fact that the Mechanism for International Criminal

Tribunals ("Mechanism") is responsible for the residual work of the Tribunal after 1 June 2013

and referring the Motion back to myself for appropriate action;<sup>3</sup>

CONSIDERING that the Trial Chamber found that the Motion falls outside the competence of

the Tribunal;<sup>4</sup>

HEREBY DISMISS the Motion without prejudice to Šešelj filing a motion before the

Mechanism.
