**I, CARMEL AGIUS**, Acting President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**NOTING** the “Appeal of Professor Vojislav Šešelj Against the Decision of Trial Chamber III on Continuation of Proceedings Dated 13 December 2013”, filed by Vojislav Šešelj on 10 January 2014 (“Motion”);<sup>1</sup>

**CONSIDERING** that President Theodor Meron has withdrawn from considering the Motion, and has assigned me to consider the Motion in his place in accordance with Rule 15(A) of the Tribunal’s Rules of Procedure and Evidence (“Rules”);<sup>2</sup>

**NOTING** that, pursuant to Rule 21 of the Rules, the Vice-President shall exercise the functions of the President in case of the latter’s absence or inability to act;

**CONSIDERING** the composition of the Appeals Chamber as set out in document IT/263/Rev. 5, issued on 4 June 2013;

**PURSUANT** to Rules 15(A) and 21 of the Rules;

**HEREBY ORDER** that the Bench in *Prosecutor v. Vojislav Šešelj*, Case No. IT-03-67-AR15bis, shall therefore be composed as follows:


