**I, THEODOR MERON**, President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

**NOTING** the "Decision on Prosecution Appeal Against the Decision on the Prosecution Motion to Revoke the Provisional Release of the Accused", rendered on 30 March 2015;

**NOTING** the "Urgent Prosecution Motion for Enforcement of Decision on Revocation of Provisional Release", filed on 14 April 2015;

**NOTING** the "Order Assigning Judges to a Case Before the Appeals Chamber", filed on 22 January 2015;

**NOTING** that the term of office of Judge William H. Sekule expired following the issuance of the Appeal Judgement in *Prosecutor v. Zdravko Tolimir*, Case No. IT-05-88/2-A, on 8 April 2015;<sup>1</sup>

CONSIDERING Articles 12 and 14 of the Statute of the Tribunal;

**NOTING** that Rule 19(A) of the Rules authorizes the President to coordinate the work of Chambers;

**CONSIDERING** the composition of the Appeals Chamber of the Tribunal as set out in document IT/263/Rev. 7, issued on 16 December 2013;
