## ORDER ON MEDICAL REPORTS

### **The Accused**

**TRIAL CHAMBER III** ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

NOTING the Chamber's Order for Medical Reports of 2 April 2009 ("Order of 2 April 2009"), in which the Chamber ordered the Registry to transmit to it two detailed reports on the health of Vojislav Šešelj ("Accused"), prepared, respectively, by the Medical Officer of the United Nations Detention Unit and a panel of medical experts appointed by the Registry ("Panel of Experts");

**NOTING** the observations of a medical team regarding the health of Mr Vojislav Šešelj ("the Accused") presented by the Accused on 5 May 2009 ("Accused's Submission");<sup>2</sup>

**NOTING** the Submissions of the Registry pursuant to Rule 33(B) of the Rules of Procedure and Evidence containing the medical reports ("Registry's Submissions");<sup>3</sup>

CONSIDERING that in the Registry's Submissions, the doctors appointed by the Registry indicate that the Accused suffers from hypertension and hepatic problems;<sup>4</sup>

CONSIDERING that in the Accused's Submissions, the doctors appointed by him expressed their concern regarding the abnormal results of medical tests that appear to indicate damage to the liver and bile system, and taking account of the Accused's cardio-vascular pathologies;<sup>5</sup>

CONSIDERING that the Chamber notes that the report from the Panel of Experts contained in the Registry's Observations does not provide precise and clear details on the tests and analyses that were conducted with a view to producing the said report;

CONSIDERING that the Chamber consequently finds that it is necessary, as a

precaution, to take all measures to ensure that the Accused receives adequate medical

treatment;

FOR THE FOREGOING REASONS, pursuant to Rule 54 of the Rules, the

Chamber **ORDERS** that:

- The Registry appoint two medical experts, of different nationalities than the

doctors previously appointed by the Registry to compose the Panel of Experts,

specialised in the treatment of cardiovascular and liver diseases, respectively,

to each submit a detailed and thorough report on the pathologies that the

Accused is suffering from and the treatment to be prescribed to him;

The Registrar ensure that it will be possible for the appointed experts to have

access to the medical equipment necessary for them to present their respective

reports and, if the need arises, to take the necessary steps with the Dutch

medical authorities to secure the co-operation of Dutch hospitals and doctors.
