**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”);

**NOTING** the Order issued confidentially and *ex parte* on 29 October 2008 by the President of the Tribunal, directing Trial Chamber II to examine the “Prosecution’s Motion under Rule 77 Concerning the Breach of Protective Measures”, filed confidentially and *ex parte* before Trial Chamber III on 10 October 2008 in the case of *Prosecutor v. Vojislav Šešelj*;

**NOTING** the Order in lieu of an Indictment issued on 21 January 2009 against Vojislav [e{elj (“Accused”) on one count of contempt of the Tribunal, punishable under Rule 77(A)(ii) of the Rules of Procedure and Evidence of the Tribunal (“Rules”), for knowingly and wilfully disclosing information in knowing violation of an order of a Chamber;<sup>1</sup>

**NOTING** that the initial appearance of the Accused was held on 6 March 2009, during which the Accused pled not guilty;<sup>2</sup>

**NOTING** that a status conference with the Accused was held on 7 May 2009 pursuant to Rule 65bis(A) of the Rules ;

**NOTING** the *Amicus Curiae* Prosecutor stated that he would be in a position to commence trial at the end of May 2009 and that the Accused expressed his immediate trial-readiness;<sup>3</sup>

**PURSUANT TO** Article 20 of the Statute of the Tribunal and Rule 54 of the Rules;

**HEREBY ORDERS** that the trial shall commence on Friday 29 May 2009 at 14:15 in Courtroom I.
