TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

PROPRIO MOTU,

NOTING the Order filed publicly by the Chamber on 19 October 2010, ordering the Registry to proceed to appoint a panel of three medical experts to examine Vojislav Šešelj ("Accused") and submit a report within two months, that is, no later than 19 December 2010 ("Order of 19 October 2010"),¹

NOTING the Order filed publicly by the Chamber on 18 November 2010, ordering that the time-limit for filing the report of the expert panel set in the Order of 19 October 2010 be amended and extended to 15 January 2011 ("Order of 18 November 2010"),²

NOTING the Order filed publicly by the Chamber on 12 January 2011, ordering that the time-limit for filing the report of this expert panel set in the Order of 18 November 2010 be extended again, to 15 February 2011 ("Order of 12 January 2011"),³

NOTING the Registry's Internal Memorandum sent to the Chamber confidentially on 10 February 2011, informing the Chamber that the expert panel was finally appointed, that the Accused was notified of its composition and that the forthcoming medical examinations would cause additional delays beyond those anticipated in the Order of 12 January 2011,

CONSIDERING that the Chamber deems that the expert panel is essentially unable to finish its task within the time-limits set in the Order of 12 January 2011,

FOR THE FOREGOING REASONS
