NOTING the "Corrigendum to the Decision of 2 November 2009 (92 *quater*)" rendered by the Chamber as a confidential document on 23 April 2010 in which the Chamber ordered that the Decision of 2 November 2009 be made confidential and that the exhibits admitted by way of this Decision be placed under seal,

CONSIDERING that the Chamber deems that it is no longer necessary to maintain the confidentiality of the Decision of 2 November 2009 or the exhibits admitted by way of this Decision and that, consequently, it is appropriate to restore the public status of the Decision of 2 November 2009 and of the exhibits admitted by way of the said Decision,

FOR THE FOREGOING REASONS
