NOTING that Tolimir is currently in custody at the United Nations Detention Unit in The Hague pending the resolution of his appeal against the Trial Judgement;

PURSUANT to Rule 65 *bis*(B) of the Rules;

HEREBY ORDER that a status conference shall be held before me on Friday, 5 July 2013 at 11:00 a.m. in Courtroom II.
