I, THEODOR MERON, Judge of the Appeals Chamber of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”) and Pre-Appeal Judge in this case;¹

NOTING the Judgement rendered in the case *Prosecutor v. Mićo Stanišić and Stojan Župljanin*, Case No. IT-08-91-T, by Trial Chamber II on 27 March 2013 (“Trial Judgement”);

CONSIDERING that pursuant to Rule 65 *bis* (B) of the Rules of Procedure and Evidence of the Tribunal (“Rules”), a status conference should be convened within one hundred and twenty days of the filing of a notice of appeal, to allow any person in custody pending appeal the opportunity to raise issues in relation thereto, including the mental and physical condition of that person;

NOTING that Mićo Stanišić (“Stanišić”), Stojan Župljanin (“Župljanin”), and the Prosecution filed notices of appeal on 13 May 2013;²


NOTING that Stanišić and Župljanin are currently in custody at the United Nations Detention Unit in The Hague pending the resolution of their respective appeals against the Trial Judgement;

PURSUANT to Rule 65 *bis* (B) of the Rules;

HEREBY ORDER that a status conference shall be held before me on 4 September 2013 at 15:00 in a courtroom to be announced by the Registry of the Tribunal.
