On 19 August 2011, the trial adjourned due to unavailability of witness Shefqet Kabashi, whose testimony is expected to commence on Monday, 22 August 2011.

Initial appearance

On 19 August 2011, the parties appeared before Judge Orić for the initial appearance of Kabashi, charged with contempt in the Haradinaj *et al.* trial. The accused chose to postpone entering a plea. A further appearance is scheduled for 26 August 2011.
