I. OVERVIEW OF COURT PROCEEDINGS

KARADŽIĆ case

Trial Chamber III – Judges Kwon (Presiding), Morrison, Baird and Lattanzi (Reserve Judge)

Rule 98bis decision

On 28 June 2012, the Chamber dismissed the accused's motion for acquittal on ten counts of the indictment but granted it in relation to the count of genocide for the crimes in several municipalities in BiH – *See Press Release number 1513, dated 28 June 2012.*

Closing arguments

From 25 until 27 June 2012, the parties presented their closing arguments. The judgement will be pronounced in due course.
