The Trial Chamber granted the Krajišnik Defence Motion for access and ordered, *inter alia*, the Registrar to provide the Defence with copies of all testimony in the Milošević proceedings, duly redacted after consultation with the Prosecution to remove all material which may identify a protected person, or which relates to the period after 30 December 1992 or which relates to Croatia or Kosovo.
