APPEALS CHAMBER JUDGEMENT

On 28 February 2005, the Appeals Chamber pronounced the Appeals Judgement in the Miroslav Kvočka, Mlado Radić, Zoran Žigić and Dragoljub Prcać case. The Appeals Chamber affirmed the sentences of Miroslav Kvočka (seven years’ imprisonment), Mlado Radić (20 years’ imprisonment), Zoran Žigić (25 years’ imprisonment) and Dragoljub Prcać (five years’ imprisonment) (see *Press Release No. 940*).

On 3 March 2005, the Deputy Registrar issued a notification confirming that Dragoljub Prcać would have served his full sentence as of 4 March 2005 and informing the President that the necessary arrangements for his release from custody in the Detention Unit would be made. Dragoljub Prcać has now been released (see *Press Release No. 941*).

GVERO and MILETIĆ Case

Judge Agius

On 2 March 2005, Milan Gvero, who was transferred to the Tribunal on 24 February 2005, and Radivoje Miletić who was transferred on 28 February 2005, appeared before Judge Agius for their initial appearance. Milan Gvero pleaded not guilty to all counts of the Indictment. Radivoje Miletić exercised

his right under Rule 62 (iii) of the Rules of Procedure and Evidence not to enter a plea at this stage. A further appearance for Radivoje Miletić will be scheduled within 30 days.

Rasim DELIĆ Case

Judge Kwon

On 3 March 2005, Rasim Delić, following his transfer to the Tribunal on 28 February 2005 appeared before Judge Kwon for his initial appearance. He pleaded not guilty to all the counts of the Indictment.

MEJAKIĆ *et al.* Case and STANKOVIĆ Case

Referral Bench – Judges Orić (Presiding), Kwon and Parker

On 3 and 4 March 2005, the Referral Bench heard submissions on the Prosecution's request for the transfer of the Mejakić *et al.* and the Stanković cases to the authorities of Bosnia and Herzegovina, pursuant to Rule 11 *bis* of the Rules of Procedure and Evidence. Representatives of the Government of Bosnia and Herzegovina participated in the hearing with regard to both cases, and representatives of the Government of Serbia and Montenegro participated with regard to the Mejakić *et al.* case, in light of its proposal that the case be transferred to the authorities of Serbia and Montenegro.
