**NOTING** the Judgement rendered by Trial Chamber II on 23 February 2011;<sup>2</sup>

**NOTING** the "Prosecution Notice of Appeal" and "Vlastimir Đorđević's Notice of Appeal", both filed on 24 May 2011;

**NOTING** that Vlastimir Đorđević is currently in custody at the United Nations Detention Unit in The Hague;

**NOTING** that the last status conference was held on 30 May 2011;

**CONSIDERING** that, pursuant to Rule 65bis(B) of the Rules of Procedure and Evidence of the Tribunal ("Rules"), a status conference should be convened within one hundred and twenty days after the last status conference, to allow any person in custody pending appeal the opportunity to raise issues in relation thereto, including the mental and physical condition of that person;

PURSUANT TO Rule 65bis(B) of the Rules;

**HEREBY ORDER** that a status conference shall be held before me on 21 September 2011 at 9:30 a.m. in Courtroom II.
