**NOTING** the judgement rendered by Trial Chamber II on 23 February 2011;<sup>2</sup>

**NOTING** the "Prosecution Notice of Appeal" and "Vlastimir Đorđević's Notice of Appeal", both filed on 24 May 2011;

**NOTING** that Vlastimir Đorđević is currently in custody at the United Nations Detention Unit in The Hague;

**CONSIDERING** that, pursuant to Rule 65 *bis* (B) of the Rules of Procedure and Evidence of the Tribunal ("Rules"), a status conference shall be convened within one hundred and twenty days after the last status conference, to allow any person in custody pending appeal the opportunity to raise issues in relation thereto, including the mental and physical condition of that person;

**NOTING** that the last status conference was held on 23 August 2012;

**PURSUANT TO** Rule 65 bis (B) of the Rules;

**HEREBY ORDER** that a status conference shall be held before me on 5 December 2012 at 9:30 a.m. in Courtroom III.
