CONSIDERING that it is in the interests of justice and all parties for the full, correct version of Exhibit P1287 to be in the e-Court system,

PURSUANT TO Rules 54 and 89 of the Rules of Procedure and Evidence,

GRANTS leave to the Prosecution to replace the version of P1287 in the e-Court system with the corrected copy contained in Annex A of the Motion.
