**I, THEODOR MERON, Presiding Judge in this case,**

**CONSIDERING** the Judgement on Sentencing Appeal rendered by the Appeals Chamber on 4 February 2005, Case No.: IT-94-2-A;

**NOTING** that paragraph 37, lines 5-7, of the Judgement on Sentencing Appeal currently reads:

"...and asserts that the description of the acts surrounding the crime does not support the finding of the Appeal Chamber that he intended to kill the victims."

but should read as follows:

"...and asserts that the description of the acts surrounding the crime does not support the finding of the Trial Chamber that he intended to kill the victims."

**NOTING** that footnote 92 at paragraph 41, of the Judgement on Sentencing Appeal currently reads:

"Sentencing Judgment, para. 178."

but should read as follows:

"Appellant's Brief, para. 138."

**NOTING** that references to three judgements made in abbreviated form at footnotes 85 and 104 of the Judgement on Sentencing Appeal, were not cited either in abbreviated form or in full in the Glossary of Terms at pages 54, and 55;

**NOTING** that the Glossary of Terms at pages 54 and 55 of the Judgement on Sentencing Appeal shall be amended to include the following references:
