NOTING that the Trial Chamber, by decision of 24 September 2007, decided on the admission of 37 documents of those 62 documents;

NOTING that the Defence now requests the admission of an additional 30 of documents, which were tendered through witness Snežana Marinković-Jekić and for which no translation or no complete translation was available at the time of her testimony;

NOTING that the Prosecution notified the Trial Chamber that it does not intend to respond to the Defence Motion;

NOTING that documents 170D and 171D are identical and that, therefore, only one document of the two should be admitted;

CONSIDERING that the remaining documents are relevant and have probative value and, thus, are admitted into evidence;

FOR THE FOREGOING REASONS,

PURSUANT TO Rules 54 and 89 of the Rules.

ADMITS into evidence the following documents:

165D, 170D, 173D, 177D, 178D, 186D, 195D, 196D, 243D, 244D, 259D, 276D, 277D, 278D, 279D, 280D, 281D, 282D, 283D, 284D, 285D, 286D, 287D, 289D, 290D, 291D, 292D, 316D and 328D.

REQUESTS the Registrar, in light of the limited time available to the Parties until the filing of their final briefs, to assign exhibit numbers to the admitted documents listed above no later than 28 September 2007;
