## ORDER WARNING LAHI BRAHIMAJ TO ADHERE TO THE TERMS OF HIS PROVISIONAL RELEASE

# UNITED NATIONS

Before:

**THE APPEALS CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Appeals Chamber" and "Tribunal", respectively),

**NOTING** that, on 3 April 2008, Trial Chamber I convicted Lahi Brahimaj for torture and cruel treatment as violations of the laws or customs of war, pursuant to Article 3 of the Tribunal's Statute, and sentenced him to a term of six years' imprisonment, subject to credit for time already spent in detention in accordance with Rule 101(C) of the Rules of Procedure and Evidence of the Tribunal ("Rules");<sup>1</sup>

**NOTING** that the Appeals Chamber is currently seised of appeals against the Trial Judgement filed by Brahimaj and the Prosecution;<sup>2</sup>

**NOTING** that, on 25 May 2009, the Appeals Chamber granted Brahimaj provisional release pursuant to Rule 65(I) of the Rules, pursuant to the following terms, among others:

The authorities of the EULEX-Kosovo Mission shall instruct Brahimaj that, during the period of his provisional release, he shall abide by the following conditions:

[...]

to comply strictly with any instructions of the authorities of the EULEX-Kosovo Mission necessary to enable them to comply with their obligations under this Decision and their guarantees;

#### [...]

The authorities of the EULEX-Kosovo Mission shall ensure that:

#### [...]

Brahimaj reports weekly to the EULEX-Kosovo Mission authorities in the place of his residence;<sup>3</sup>

**CONSIDERING** that the EULEX-Kosovo Mission, in its weekly report dated 19 February 2010, states that Brahimaj failed to appear at a pre-arranged weekly meeting at his residence;<sup>4</sup>

**WARNS** Lahi Brahimaj that his provisional release will be terminated in the event that he fails to comply with any instructions of the authorities of the EULEX-Kosovo Mission necessary to enable it to comply with its obligations in relation to his provisional release.
