
**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 (“Tribunal”),

**NOTING** the “Order Assigning Judges to a Case before a Trial Chamber” issued by the President of the Tribunal on 21 July 2010 assigning the case of *Prosecutor v. Ramush Haradinaj et al.*, Case No. IT-04-84bis-PT to this Chamber;

Pursuant to Rules 54 and 73bis of the Rules of Procedure and Evidence hereby **ORDERS**

- (1) a Pre-Trial Conference shall be held on Wednesday, 17 August 2011 at 14:15 hours in a courtroom designated by the Registry;
- (2) the trial shall commence on Thursday, 18 August 2011;
- (3) in the first three months of trial the Chamber will sit on the following days: 18, 19, 20 August, 22 to 26 August, 29 August to 2 September, 26 to 30 September, 3 to 7 October, 24 to 28 October, 31 October to 4 November, 21 November to 25 November, 28 November to 2 December 2011.
