NOTING the "Order Reassigning a Case to a Trial Chamber," issued by the President of the

International Tribunal on 21 August 2008, which reassigned Prosecutor v. Radovan Karadžić, Case

No. IT-95-5/18-I, from Trial Chamber I to Trial Chamber III;

NOTING the "Order on Composition of Pre-Trial Bench," issued by myself as the then Presiding

Judge of Trial Chamber III on 22 August 2008, determining that the Pre-Trial Bench in the present

case shall be composed of myself, presiding, Judge Iain Bonomy, and Judge Michèle Picard and

designating Judge Iain Bonomy as Pre-Trial Judge;

NOTING the "Order Replacing a Judge in a Case Before a Trial Chamber", issued by myself on 18

November 2008, in which I assigned Judge Christoph Flügge to replace myself on the Bench in the

present case;

NOTING that Rule 19 of the Rules of Procedure and Evidence of the International Tribunal

authorizes the President of the International Tribunal to coordinate the work of the Chambers;

**CONSIDERING** the composition of the Trial Chambers of the International Tribunal as set out in

document IT/261 issued on 17 November 2008;

**CONSIDERING** the trial management and case distribution needs of the International Tribunal;

HEREBY ASSIGN, effective 1 September 2009, Judge O-Gon Kwon to replace Judge Iain

Bonomy on the Bench in the present case.
