THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal"),

NOTING its "Decision on Site Visit" filed confidentially on 28 January 2011 ("Decision"), in which it ordered, *inter alia*, that a site visit to locations in and around Sarajevo would take place in May 2011 ("Site Visit") and that the "confidentiality of all site visit related pleadings shall be maintained until further order of the Chamber";¹

CONSIDERING that, given the Site Visit has been completed, there are no longer exceptional reasons for the Decision and all Site Visit related pleadings to remain confidential;

FOR THE FOREGOING REASONS

PURSUANT to Article 21(2) of the Statute of the Tribunal and Rules 78 and 79

HEREBY ORDERS the Registry to lift the confidentiality of the:

- 1) Decision;
- 2) "Submission on Site Visit", filed by the Accused on 6 October 2010;
- 3) "Prosecution's Submission on Site Visit", filed by the Office of the Prosecutor ("Prosecution") on 7 October 2010;
- 4) "Order on Submissions for a Site Visit", issued by the Chamber on 15 November 2010;
- 5) "Second Submission on Site Visit", filed by the Accused on 13 December 2010;
- Prosecution's Second Submission on Site Visit", filed by the Prosecution on 14 December 2010;
- "Registry Submission Pursuant to Rule 33(B) on the Presence of the Accused during a Potential Site Visit", filed by the Registry on 14 January 2011; and
