**THIS TRIAL CHAMBER** of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

**BEING SEISED OF** the Accused's "Request for Reclassification of Witness KDZ182 and KDZ450 Transcripts", filed publicly on 9 January 2015 ("Request"), wherein the Accused requests that the confidentiality of various portions of the transcripts of the testimony of Witnesses KDZ182 and KDZ450 be lifted;<sup>1</sup>

**ORDERS** that the Registry lift the confidentiality of the portions of the transcripts of Witnesses KDZ182 and KDZ450 identified in footnote 1 of this Order as well as the respective audio-visual records.
