THE APPEALS CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Appeals Chamber" and "International Tribunal", respectively);

**BEING SEIZED** of the "Request to Lift Confidentiality of Appendices to Supplemental Brief" and the "Request to Lift Confidentiality of Prosecution Filings Pursuant to Appeals Chamber's Order", both filed by the Prosecution on 11 February 2009 ("First Request" and "Second Request", respectively);

**NOTING** that in the First Request, the Prosecution asks the Appeals Chamber to lift the confidential status of the appendices to its "Consolidated Supplemental Brief on the Additional Evidence of George Mano, Stefan Karganović, Radovan Karadžić and Nicholas Stewart", filed confidentially on 18 November 2008 ("Appendices" and "Supplemental Brief", respectively); <sup>1</sup>

**NOTING** that in the Second Request, the Prosecution asks the Appeals Chamber to lift the confidential status of the "Prosecution's Motion to Adduce Rebuttal Material", filed confidentially on 15 September 2008 ("Motion of 15 September 2008") and the "Urgent Prosecution Request to Direct the Registry and Krajišnik to Disclose Certain Correspondence and Decisions", filed confidentially on 27 October 2008" ("Request of 27 October 2008");<sup>2</sup>

**NOTING** that Momčilo Krajišnik has not filed a response;

**RECALLING** its "Order Lifting Confidentiality" of 23 January 2009, in which the Appeals Chamber lifted the confidential status of certain decisions and orders in this case and ordered "the parties and *Amicus Curiae* to file public redacted versions of their submissions adjudicated" in those decisions and orders by 16 February 2009;<sup>3</sup>

**NOTING** that the Prosecution argues that the Appendices were "inadvertently" filed confidentially and that "none of the exhibits and excerpts of testimony contained in the appendices are in fact confidential":<sup>4</sup>

NOTING the Prosecution's argument in relation to the Motion of 15 September 2008 and the Request of 27 October 2008 that the Appeals Chamber had ordered "to lift the confidentiality of Exhibits AD1, AD2, AD6-9, AP1-AP7 and the evidence of George Mano, Stefan Karganović and

Nicholas Stewart's evidence (save for limited exceptions)" and that consequently, "there is no need for the filings to remain confidential";5

CONSIDERING that in these circumstances no valid reason exists why the Appendices, the Motion of 15 September 2008 and the Request of 27 October 2008 should remain confidential;

HEREBY GRANTS the First Request and the Second Request and ORDERS that the confidential status of the following documents be lifted:

- 1. "Appendices to the Consolidated Supplemental Brief on the Additional Evidence of George Mano, Stefan Karganović, Radovan Karadžić and Nicholas Stewart" of 18 November 2008 (A8092-A7537)
- 2. "Prosecution's Motion to Adduce Rebuttal Material" of 15 September 2008 (A7105-A7076)
- 3. "Urgent Prosecution Request to Direct the Registry and Krajišnik to Disclose Certain Correspondence and Decisions" of 27 October 2008 (A7283-A7279).
