I, Mehmet Güney, Acting President of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“International Tribunal”),

NOTING the “Order Assigning Judges to a Case Before the Appeals Chamber”, issued on 22 July 2009;

NOTING the “Order Replacing a Judge in a Case Before the Appeals Chamber”, issued on 19 May 2011;

NOTING that President Patrick Robinson is currently absent from the International Tribunal and that, pursuant to Rule 21 of the Rules of Procedure and Evidence of the International Tribunal (“Rules”), the Vice-President shall exercise the functions of the President in case of the latter’s absence or inability to act;

NOTING that Vice-President O-Gon Kwon is currently absent from the International Tribunal and that, pursuant to Rule 22(A) of the Rules, if neither the President nor the Vice-President remains in office or is able to carry out the functions of the President, these shall be assumed by the senior permanent Judge, determined in accordance with Rule 17(C) of the Rules;

CONSIDERING Articles 12(3) and 14(3) of the Statute of the International Tribunal and Rule 108 of the Rules;

CONSIDERING that Rule 19(A) of the Rules authorises the President to coordinate the work of the Chambers;

CONSIDERING that the President, pursuant to Rule 27(C) of the Rules, may at any time temporarily assign a member of a Trial Chamber to another Chamber;

CONSIDERING the composition of the Trial Chambers of the International Tribunal as set out in document IT/272, issued on 28 February 2011;

CONSIDERING the composition of the Appeals Chamber of the International Tribunal as set out in document IT/263, issued on 11 May 2009;

CONSIDERING the trial management and case distribution needs of the International Tribunal;

HEREBY ASSIGN, effective immediately, Judge Howard Morrison to replace Judge Bakone Justice Moloto on the Bench seised of the present case; and
