**I, Patrick Robinson**, Presiding Judge of Trial Chamber III of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 (“Tribunal”);

**NOTING** the “Order assigning a Case to a Trial Chamber” issued by the President of the Tribunal on 20 February 2006, assigning the case of *Prosecutor v. Milan Lukić and Sredoje Lukić*, Case No. IT-98-32/1-PT to Trial Chamber III,

**NOTING** the “Order regarding Composition of Trial Chamber and Designating a Pre-Trial Judge” issued by the Presiding Judge of Trial Chamber III, filed on 18 May 2006, ordering that, for the purposes of pre-trial proceedings, Trial Chamber III be composed of Judge Patrick Robinson, Judge Krister Thelin and Judge Frank Höpfel, and designating Judge Thelin as pre-trial Judge,

**CONSIDERING** the “Order Assigning an *ad litem* Judge to Pre-Trial Proceedings” issued by the President on 29 May 2008, assigning Judge Pedro David to Trial Chamber III for the purposes of pre-trial proceedings in the instant case,

**CONSIDERING** the “Order Assigning a Judge to a Trial Chamber” also issued by the President on 29 May 2008, assigning Judge Christine Van den Wyngaert, to Trial Chamber III for the purposes of this case,

**HEREBY ORDER** that, in the case of *Prosecutor v. Milan Lukić and Sredoje Lukić*, Trial Chamber III shall be composed, for the purposes of pre-trial proceedings, as follows:


Judge Patrick Robinson (Presiding)
