THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991;

BEING SEISED OF "Vujadin Popović's Request for an Extension of Time to File the Expert Report of Mr. Miladin Kovačević", filed on 1 May 2008 ("Popović Request"), in which Popović requests an extension of time until 14 May 2008 to file Mr. Miladin Kovačević's expert report on statistics and demography ("Kovačević Report");¹

ALSO BEING SEISED OF two respective requests filed on 1 May 2008, in which Beara, Nikolić, and Pandurević request an extension of time until 15 May 2008 to file the English translation of the expert report of Professor Svetlana Radovanović ("Radovanović Report") ("Beara, Nikolić, and Pandurević Request");² and Popović requests an extension of time to file the English translation of the expert report of Professor Dušan J. Dunjić ("Dunjić Report") "three days after the Defence receives it from [...] CLSS" ("Second Popović Request");³

NOTING the "Notice of Disclosure of the Expert Witness Report of Professor Ljubomir Gogić by Ljubiša Beara Pursuant to Rule 94 *bis*" and the "Notice of Disclosure of the Expert Witness Report of Professor Dr. Slobodan Remetić by Ljubiša Beara Pursuant to Rule 94 *bis*", filed on 1 May 2008 ("Gogić and Remetić Reports"), by which Beara only submitted the two expert reports in BCS and states his intent to submit the two expert reports for translation into English;

NOTING the "Response to Defence Requests for Extensions to File English Translations of Non-Military Export Reports and to Popović Request for Extension to File Demographic Report", filed on 5 May 2008 ("Response"), in which the Prosecution does not oppose the Popović Request for an

extension of time until 14 May 2008,⁵ and a delayed filing of the English translations of the four expert reports if the English translations are filed no later than 15 May 2008;⁶

NOTING the Trial Chamber's oral order rendered on 13 December 2007 which amended the "Order on Close of Prosecution Case-in-Chief, Rule 98 *bis* Proceedings, Defence Rule 65 *ter* filings, Pre-Defence Conference and Commencement of the Defence Case" filed on 29 November 2007, in which each Accused was ordered to serve upon the Prosecution and the Trial Chamber expert reports by 30 April 2008;⁷

CONSIDERING that the Prosecution does not object to the Popović Request and a delayed filing of the four expert reports if the English translations are filed no later than 15 May 2008;

PURSUANT TO Rule 54 of the Rules,

HEREBY GRANTS the Popović Request and the Beara, Nikolić, and Pandurević Request, **PARTLY GRANTS** the Second Popović Request and **ORDERS** as follows:

- 1. The Kovačević Report shall be filed no later than 14 May 2008;
- The English translations of the Radovanović Report, the Dunjić Report and the Gogić and Remetić Reports shall be filed no later than 15 May 2008.
