THIS TRIAL CHAMBER of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the former Yugoslavia since 1991 ("Tribunal");

BEING SEISED OF the "Defence Motion on Behalf of Drago Nikolić Seeking Access to Confidential Material in Case No. IT-02-60/1", filed on 29 June 2007 ("Motion"), in which Drago Nikolić seeks access to all confidential material in the case of *Prosecutor v. Momir Nikolić*, including, *inter alia*, "exhibits, filings (as well as Momir Nikolić's sentencing brief), all 92bis witness statements and the testimonies of *viva voce* witnesses"; ¹

NOTING that, pursuant to Rule 75(I), "[b]efore determining an application under paragraph (G)(ii), (H)(ii), or (H)(iii) above, the Chamber shall endeavour to obtain all relevant information from the first proceedings, including from the parties to those proceedings, and shall consult with any Judge who ordered the protective measures in the first proceedings, if that Judge remains a Judge of the Tribunal";

PURSUANT TO Rules 54 and 75(I) of the Rules,

HEREBY REQUESTS the assistance of the Registry in serving Momir Nikolić with the Motion, and **DECIDES** that Momir Nikolić has until 21 September to respond, should he wish to do so.
