## DECISION ON PRLIĆ DEFENCE MOTION FOR ADMISSION OF DOCUMENTARY EVIDENCE

#### I. INTRODUCTION

1. Trial Chamber III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal") is seized of "Jadranko Prlić's Motion for the Admission of Documentary Evidence", to which three annexes are attached ("Motion"), filed on 5 December 2008 by Counsel for the Accused Prlić ("Prlić Defence"), in which the Prlić Defence requests the admission of 1135 documents into evidence ("Proposed Exhibits").

#### II. PROCEDURAL BACKGROUND

- 2. In an email dated 17 December 2008, the Chamber granted the parties an extension of time until 20 January 2009 to respond.
- 3. On 19 December 2008, the Chamber rendered the "Decision on Prlić Defence Motion for the Admission of Documentary Evidence" ("Decision of 19 December 2008") in which it first found that the Prlić Defence had not revealed the source of some of the Proposed Exhibits, but without applying for protective measures for them. The Chamber therefore directed the Prlić Defence to file a motion in due form requesting protective measures for the Proposed Exhibits.
- 4. In the Decision of 19 December 2008, the Chamber also noted that, while the Prlić Defence had classified the Proposed Exhibits according to subject, a large number of Proposed Exhibits were classified into overly-general categories. Consequently, the Chamber directed the Prlić Defence to classify these Proposed Exhibits into more specific categories, referring to the amended indictment of 11 June 2008 ("Indictment").
- 5. On 4 January 2009, the Prlić Defence filed "Jadranko Prlić's Motion for Protective Measures of Certain Documents and Additional Classification of Certain Subjects Included in the Motion for Admission of Documentary Evidence" ("Motion for Protective Measures"). By way of this Motion for Protective Measures, the Prlić Defence requests the leave of the Chamber to use pseudonyms to designate the sources that gave documents to the Prlić Defence from their private archives, on condition that their identity remains confidential and that the said documents are

designated confidential. Furthermore, the Prlić Defence proposes a further and more specific classification of the categories previously called "municipalities – general" and "HVO HZ H-B – general."

- 6. On 20 January 2009, the Office of the Prosecutor ("Prosecution") filed the "Prosecution Response to Jadranko Prlić's (1) Motion for Admission of Documentary Evidence and (2) Motion for Protective Measures of Certain Documents & Additional Classification of Certain Subjects Included in the Motion for Admission of Documentary Evidence", to which a confidential annex is attached ("Response").
- 7. On 20 January 2009, the Prosecution further filed the confidential "Prosecution Motion to Redact Reference to a Closed Session Witness from a Public Filing of the Prlić Defence".
- 8. On 27 January 2009, the Chamber confidentially rendered the "Order on the Confidentiality of a Motion Filed Publicly by the Prlić Defence" in which it ordered that the Motion and its annexes be made confidential and requested that the Prlić Defence file, prior to 3 February 2009, a new public motion for admission, in which any reference to a witness for whom protective measures have been ordered shall have been redacted.
- 9. On 28 January 2009, the Prlić Defence filed "Jadranko Prlić's Public Revised Version of the Motion for the Admission of Documentary Evidence", to which 3 annexes were attached ("Public Motion").
- 10. On 28 January 2009, the Defence further filed "Jadranko Prlić's Request for Leave to Reply & Reply to Prosecution Response to Jadranko Prlić's (1) Motion for Admission of Documentary Evidence and (2) Motion for Protective Measures of Certain Documents & Additional Classification of Certain Subjects Included in the Motion for Admission of Documentary Evidence" ("Reply").
- 11. Finally, on 10 February 2009, the Prlić Defence filed "Jadranko Prlić's Submission of Video Material" in which it gave certain information concerning the videos tendered for admission in the Public Motion ("Submission of 10 February 2009").

#### III. ARGUMENTS OF THE PARTIES

- 12. In the Public Motion, the Prlić Defence submits that the Proposed Exhibits are all relevant, reliable and probative, as indicated in Annex 1, and that they have been presented in compliance with Guideline 9 of the Decision Adopting Guidelines for the Presentation of Defence Evidence of 24 April 2008 ("Guideline 9"). The Prlić Defence states that it did not present the Proposed Exhibits through a witness since the Chamber strictly limited the time it had available to present its evidence and because of the number of documents that could be presented through Neven Tomić. The Prlić Defence further submits that Chamber should admit the lengthy documents in their entirety in order to place their content into context.
- 13. In the Motion for Protective Measures, the Prlić Defence submits that certain documents ("Anonymous Documents") were provided to it by private individuals ("Sources") for use in the trial, on condition that their source remain confidential and that they be designated confidential. The Prlić Defence submits that not revealing the source of a document does not prevent the Chamber and the other parties from assessing its reliability.
- 14. In the Response, the Prosecution requests that the Chamber deny the Motion for Protective Measures and deny the admission of the documents it requests be rejected in its annex, for the reasons stated therein or for such other reason as the Chamber determines.<sup>6</sup> In particular, the Prosecution requests that certain videos be rejected, since it asserts that it does not have the videos themselves but only transcriptions of them.<sup>7</sup>
- 15. In support of the Response, the Prosecution first submits that the Prlić Defence has violated Guideline 9 (a) (ii), which requires that the source of the exhibit, as well as a description of the indicia of reliability be indicated for each exhibit tendered for admission.<sup>8</sup> The Prosecution further submits that there is no precedent or basis to

support the admission of documents originating from unofficial or private sources known only to the party presenting them, and excluding any other. Finally, the Prosecution notes that the Prlić Defence has in no way demonstrated how the Sources would be endangered if their identity were to be revealed to the Prosecution or to the Chamber, and that under such circumstances it is impossible to assess the need to grant the protective measures requested. 10

16. In the Reply, the Defence submits that Guideline 9 simply states that in the absence of information such as the source and indicia of reliability, the motion may be denied, and that while no rule or decision of the Tribunal deals directly with the issue of anonymous documentary evidence, there is also no indication that such evidence is not admissible. 11 The Prlić Defence further submits that it is absurd to state that the Chamber must know the identity of the sources concerned to decide whether or not to maintain their anonymity, and maintains that depriving these Sources of their anonymity would scare away all of the other sources who might one day be useful.<sup>12</sup> The Prlić Defence further states that since Rule 70 of the Rules of Procedure and Evidence ("Rules") authorizes the Prosecution not to reveal to the Defence the identity of sources that provide it information on a confidential basis without prejudicing the Defence, the anonymity of these Sources should not prejudice the Prosecution. 13 Finally, the Prlić Defence argues that the Anonymous Documents are similar to hearsay evidence, in other words, they may be accorded limited weight but are still admissible. 14

17. In the Submission of 10 February 2009, the Prlić Defence states that the videos mentioned in the Response were in fact partially disclosed to the Prosecution on 7 April, 21 April and 2 June 2008. The Prlić Defence next provides explanations as to why it is not in a position to provide the remainder of the videos it tenders for admission in its Public Motion. He

#### IV. DISCUSSION

- 18. As a preliminary matter, the Chamber decides to authorize the Reply since the Prlić Defence provides clarifications of the arguments set forth in the Motion for Protective Measures.
- 19. For the sake of clarity, the Chamber will first deal with the admission of the Anonymous Documents and at the same time the Motion for Protective Measures, before turning to the admission of the other Proposed Exhibits.

# A. The Motion for Protective Measures and the Admission of Anonymous Documents

- 20. Firstly, the Chamber notes that the Prlić Defence requests that the Sources of the Anonymous Documents be protected not only from the public and the media, but also that they not be disclosed to the other Defence teams, to the Prosecution and to the Chamber itself.
- 21. Contrary to the Prlić Defence claim, it is not "entirely contradictory" for the Chamber know the identity of the source of a document in order to rule on protective measures or even the admission of a document, especially since the Prlić Defence only seems to argue that it agreed with the Sources concerning the use of the Anonymous Documents in the proceedings, without further details. The Chamber further notes that the Prlić Defence seems to rely on Articles 20 and 22 of the Statute of the Tribunal ("Statute") and on Rules 69, 70 and 75 of the Rules to request such an exceptional measure as complete anonymity, but fails to explain how these provisions should apply to this case. 18
- 22. The Chamber would like to remind the Prlić Defence that the granting of protective measures under Rules 75 and 70 is governed by specific procedures with well-established criteria.
- 23. The Chamber indeed reminds the Prlić Defence that in order for a protective measure to be granted under Rule 75 of the Rules, Tribunal jurisprudence requires that there be evidence of a real fear for the security of the person and/or that of his/her

family. As the Prlić Defence has not provided any information about these Sources, the Chamber is unable to determine whether the protective measures are necessary under Rule 75 of the Rules.

- 24. The Chamber also notes that Rule 70 as well as Tribunal jurisprudence allow for the disclosure of confidential information by States, international organizations or individuals, safeguarding the confidential nature of their information and protecting their identity. The Chamber may not, however, apply Rule 70 of the Rules without knowing the details of the consent of the Sources or their identity. Moreover, the Chamber draws the attention of the Prlić Defence to the fact that, although these protective measures would be granted under Rule 70 (B) and (F) of the Rules, such information and its source may not under any circumstances be used as evidence without prior disclosure to the parties.
- 25. Consequently, in view of the scarce information provided by the Prlić Defence in its Motion for Protective Measures, the Chamber is unable to grant protective measures to these Sources. Furthermore, with regard to the procedure for granting protective measures in force at the Tribunal, the Prlić Defence should have never promised these Sources complete anonymity.
- 26. Secondly, the Chamber notes that the Prlić Defence requests the admission of 356 Anonymous Documents. The Chamber wishes to recall that since the Prlić Defence refuses to disclose the identity of the Sources, including to the Chamber, the Prlić Defence places the Chamber in a position where it is unable to assess the reliability and authenticity of these Anonymous Documents. Under these circumstances, the Chamber denies the request for admission of these Anonymous Documents.

#### B. The Request for Admission of the Other Proposed Exhibits

27. With regard to the remainder of the Proposed Exhibits, the Chamber has encountered various types of problems in the analysis of the Proposed Exhibits to rule on their admissibility and their admission.

- 28. Firstly, the Chamber notes that, according to the Prlić Defence, a certain number of Proposed Exhibits originate from various archives, and in particular from those of municipalities. Nonetheless, the Chamber has found no indication, such as an archives stamp or headings from Official Gazettes, on the Proposed Exhibits themselves, to determine that they in fact originate from these archives. Furthermore, the Prlić Defence has provided no explanation as to how it obtained these Proposed Exhibits or why these exhibits do not contain the indicia necessary for the Chamber to rule on the admission of a piece of evidence. Accordingly, the Chamber considers that it lacks the sufficient indicia of reliability and authenticity to be able to admit these Proposed Exhibits.
- 29. Secondly, the Chamber finds that a certain number of Proposed Exhibits relate to municipalities outside the scope of the Indictment. The Chamber notes that the Prlić Defence fails to provide any explanation as to the reasons why it considers that these Proposed Exhibits are important for the determination of the case, as is required by Guideline 9 (a) (vi), which is particularly important for documents related to municipalities situated outside of the Indictment. In fact, in Annex 1 to the Public Motion, the Prlić Defence merely described the content of the Proposed Exhibits without explaining their link to the Indictment. The Chamber therefore rejects the Proposed Exhibits related to municipalities situated outside of the Indictment for which the Prlić Defence has provided no explanation allowing the Chamber to determine whether they bear sufficient indicia of relevance.
- 30. Thirdly, the Chamber notes that it does not have certain videos tendered for admission by the Prlić Defence, but only a transcription of them. The Chamber notes nonetheless that, contrary to the Prosecution claim, most of the videos tendered for admission were disclosed to it in April and June 2008.<sup>20</sup> The Chamber finds that the Prlić Defence nonetheless states that it does not have some videos, namely Exhibits 1D 01319, 1D 00912, 1D02227, 1D 02304, 1D 02347 and 1D 02844, which it has tendered for admission.<sup>21</sup>

- 31. The Chamber first notes that video 1D 02844 was indeed disclosed by the Prlić Defence on 21 April 2008.<sup>22</sup> Conversely, with regard to the other videos, the Chamber reminds the Prlić Defence that, clearly, it must have the videos in order to admit them, where appropriate, and that it would be unreasonable for it to admit merely a transcription of them. The Chamber in fact has no information about how the transcriptions were done, or any other way of verifying their accuracy. The Chamber therefore rejects Exhibits 1D 01319, 1D 00912, 1D02227, 1D 02304 and 1D 02347.
- 32. The Chamber finds that the Proposed Exhibits marked 1D 00239, 1D 00244, 1D 00549, 1D 00558, 1D 00578, 1D 0635, 1D 00960, 1D 00980, 1D 00990, 1D01699, 1D 02338, 1D 02471, 1D 02523 and 1D 02716 have already been admitted through various decisions of the Chamber. Accordingly, the Chamber decides that the Public Motion in respect of the Proposed Exhibits is moot.
- 33. Concerning the other Proposed Exhibits, the Chamber finds that the Prlić Defence has provided the information required by Guideline 9 in the annexes attached to the Public Motion.
- 34. The Chamber wishes to note that, at this stage of the trial, it will only carry out an examination of the admissibility of the Proposed Exhibits tendered for admission, and need not make a final assessment of their probative value. It will do so only at the end of the trial, after all of the evidence has been admitted into the record. In carrying out this evaluation, the Chamber will take into particular account the fact that contradictions may exist between exhibits; that the Prosecution disputes the Prlić Defence's interpretation of them or their authenticity; that certain information amounts to hearsay and that the Prosecution did not have the opportunity to test the Proposed Exhibits in cross-examination.
- 35. In view of the information provided by the Prlić Defence in the Public Motion and in the Reply, and of the objections raised by the Prosecution to each Proposed Exhibit, the Chamber decides to admit the Proposed Exhibits which are indicated "Admitted" in the annex attached to the present decision, since they bear sufficient indicia of reliability, relevance and probative value with respect to the Indictment and that, accordingly, it is appropriate to admit them.

36. Finally, the Chamber rejects the Proposed Exhibits which are indicated "Not admitted" in the annexed attached to the present decision, specifying in the same

annex the reasons why each Proposed Exhibit has been rejected.

37. Incidentally, the Chamber notes that certain BCS originals and translations of

the Proposed Exhibits have been reversed in the e-court system. The Chamber

therefore calls upon the Prlić Defence to correct this in the e-court system.

FOR THESE REASONS,

IN ACCORDANCE WITH Rule 89 (C) of the Rules,

**AUTHORIZES** the Reply,

DISMISSES AS MOOT the Public Motion with regard to Proposed Exhibits

1D 00239, 1D 00244, 1D 00549, 1D 00558, 1D 00578, 1D 00635, 1D 00960, 1D

00980, 1D 00990, 1D01699, 1D 02338, 1D 02471, 1D 02523 and 1D 02716 for the

reasons set out in the attached Annex,

ADMITS into evidence the Proposed Exhibits indicated "Admitted" in the Annex

attached to the present decision,

**DENIES** the Public Motion in all other respects, for the reasons set out in the attached

Annex, AND

**ORDERS** the Prlić Defence to make the necessary changes in the e-court system as

indicated in the present decision.
