# ORDER TO ADMIT EVIDENCE REGARDING WITNESS MIOMIR ŽUŽUL

**TRIAL CHAMBER III** ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal"),

**NOTING** the requests for admission filed by Counsel for the Accused Prlić ("Prlić Defence"), the Office of the Prosecutor ("Prosecution"), Counsel for the Accused Praljak ("Praljak Defence") and Counsel for the Accused Petković ("Petković Defence") in which they request respectively the admission of 20, 19, 1 and 4 exhibits regarding the testimony of Miomir Žužul<sup>1</sup> who appeared from 6 to 8 May 2008 and from 21 to 22 July 2008<sup>2</sup> ("Proposed Exhibits"),

**NOTING** the written submission filed by the Prosecution on 24 July 2008, in which it objects to the admission of exhibits 1D 01556, 1D 01713, 1D 2895 and 1D 02902 submitted for admission by the Prlić Defence on the ground that the Prlić Defence did not present these exhibits to the witness at the hearing,<sup>3</sup>

NOTING the written submission filed by the Praljak Defence on 24 July 2008 in which it objects to the admission of exhibits P 10553, P 10554 and P 10557 submitted for admission by the Prosecution on the ground that these exhibits were not presented to the witness by the Prosecution at the hearing; in particular with regard to Exhibit P10554, which is the printout of a web page illegally reproducing song lyrics, the Praljak Defence considers that this exhibit lacks reliability, has no connection to the crimes as alleged in the Indictment and has no probative value,<sup>4</sup>

**NOTING** the written submission filed by the Ćorić Defence on 26 July 2008, in which it objects to the admission of Exhibit P 10554 submitted for admission by the

Prosecution on the ground that this exhibit was not presented to the Witness by the Prosecution at the hearing, and that it lacks relevance and probative value,<sup>5</sup>

**NOTING** the withdrawal request filed by the Prosecution on 28 July 2008, in which it requests the Chamber to authorise it to withdraw the request to admit Exhibit P 10554 (Prosecution Withdrawal of Request for Admission of Exhibit P 10544 in Relation to Witness Miomir Žužul),<sup>6</sup>

CONSIDERING that the Chamber has examined each of the Proposed Exhibits on the basis of the admissibility criteria set out in its Decision on Admission of Evidence, rendered by the Chamber on 13 July 2006 ("Decision of 13 July 2006") and on the Decision Adopting Guidelines for the Presentation of Defence Evidence, rendered by the Chamber on 24 April 2008 (Decision of 24 April 2008),<sup>7</sup>

CONSIDERING that the Chamber has examined exhibits 1D 01556, 1D 01713, 1D 2895 and 1D 02902, submitted for admission by the Prlić Defence, as well as exhibits P 10553, P 10554 and P 10557, submitted for admission by the Prosecution, in light of the objections raised by the Parties, 8

**CONSIDERING** that the Chamber decides to admit into evidence the Proposed Exhibits indicated "admitted" in the Annex attached to this Decision since they were put to Witness Miomir Žužul and bear sufficient indicia of relevance, probative value and reliability,

**CONSIDERING** that the Chamber decides not to admit into evidence the Proposed Exhibits indicated "not admitted" in the Annex attached to this Decision since they are not consistent with the instructions set out in the Decisions of 13 July 2006 and 24 April 2008,

**CONSIDERING** that the Chamber reminds the Parties to indicate in their requests for admission the *e*court pages of the exhibits requested for admission,

#### FOR THE FOREGOING REASONS,

PURSUANT TO Rules 54 and 89 of the Rules of Procedure and Evidence,

GRANTS the Prosecution Withdrawal of Request for Admission of Exhibit P 10544,

GRANTS the request for admission by the Praljak Defence,

PARTIALLY GRANTS the requests for admission by the Prlić Defence, the Petković Defence and the Prosecution,

**DENIES** in all the other respects the requests of the Prlić Defence, the Petković Defence and the Prosecution for the reasons stated in the Annex attached to this Decision **AND** 

**DECLARES MOOT** the request of the Prlić Defence regarding two pages of Exhibit 1D 02910 and four pages of Exhibit 1D 02911 for the reasons stated in the Annex attached to this Decision.

**DECLARES MOOT** the Prosecution request concerning 18 pages of Exhibit P 07856 and Exhibit P 10481 for the reasons stated in the Annex attached to this Decision,

**DECIDES** that the documents indicated "admitted" in the Annex attached to this Decision should be admitted into evidence,

**DECIDES** that the documents indicated "not admitted" in the Annex attached to this Decision should not be admitted into evidence,
