TRIAL CHAMBER III ("Chamber") of the International Tribunal for the Prosecution of Persons Responsible for Serious Violations of International Humanitarian Law Committed in the Territory of the Former Yugoslavia since 1991 ("Tribunal");

NOTING the Appeals Chamber decision dated 16 September 2008, in which the Appeals Chamber denied the appeal lodged by the Prosecution against the Order Regarding the Resumption of Proceedings, rendered by the Chamber on 15 August 2008 ("Appeals Chamber Decision" and "Order on Resumption", respectively);

CONSIDERING that the Appeals Chamber finds that the Chamber did not abuse its discretionary power by ordering that the hearings could continue while awaiting the Chamber's decision on the Prosecution motion to impose counsel;²

CONSIDERING that the hearings have been suspended since 26 August 2008³ and it is therefore necessary to resume proceedings as rapidly as possible;

FOR THE FOREGOING REASONS

PURSUANT TO Rule 54 of the Rules

ORDERS the Prosecution to submit to the Chamber and the Accused, no later than 19 September 2008, a schedule of witnesses who will testify starting with Wednesday, 24 September 2008, and for the following two months, and

DECIDES that a hearing will take place on Tuesday, 23 September 2008, in order to go over pending administrative questions.
