Status Conference

On 13 November 2013, the parties met before Judge Agius for a Status Conference. Judge Agius stated at the Conference that he expected the appeal judgement to be rendered in January or early February next year.

ORDER ASSIGNING A SINGLE JUDGE

On 12 November 2013, the MICT President Meron assigned Judge Moloto to deal with the Karadžić's request to consider whether to appoint an *amicus curiae* prosecutor to investigate possible contempt by former ICTY Prosecutor Del Ponte.

DECISION ON APPEAL AGAINST THE DECISION ON THE ACCUSED'S MOTION TO SUBPOENA ZDRAVKO TOLIMIR

On 13 November 2013, the Appeals Chamber denied the appeal by Zdravko Tolimir against the decision issuing a subpoena against him in order to testify as a Defence witness in Karadžić trial.
